Call to Order

Daniel Eisinger, Co-Chair of the Criminal Justice Subcommittee, called the meeting to order at 4:03 pm.

April Co-Chair Meeting Minutes

The Criminal Justice Subcommittee meeting minutes on May 12, 2021, were reviewed and minor fixes were made.

May Subcommittee Meeting Agenda

Kayla Elson, of Justice & Sustainability Associates, introduced a draft agenda for the Criminal Justice Subcommittee meeting on June 23, 2021. Subcommittee members will discuss the information learned from the Action Summit, West Palm Beach Police Department standard operation policies, and creating public police advisory boards. The agenda was adjusted to have a shorter conversation about current standard operation policies and a more robust conversation about a police advisory board. Tiffany David, of the City of West Palm Beach, will reach out to the activist group that spoke out against establishing a police review board to invite them to a Criminal Justice Subcommittee meeting.

Alexcia Cox, Co-Chair of the Criminal Justice Subcommittee, inquired about the subcommittee's timeline for making recommendations. While there is no set deadline for subcommittee members to have their recommendations ready, Alexcia Cox recommended that the Criminal Justice Subcommittee members schedule a workshop in addition to the monthly subcommittee meeting to start drafting recommendations to Mayor James. The Co-Chairs will aim to draft a recommendation for at least one of the priorities in the upcoming months.

Kayla Elson provided an update on preparations for the June 12th Action Summit and explained the run-of-show for the day of the Action Summit.
